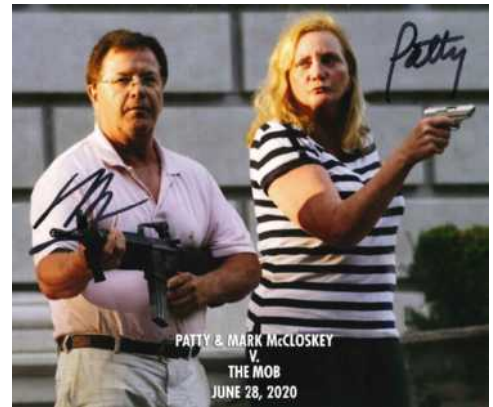


MEET MARK

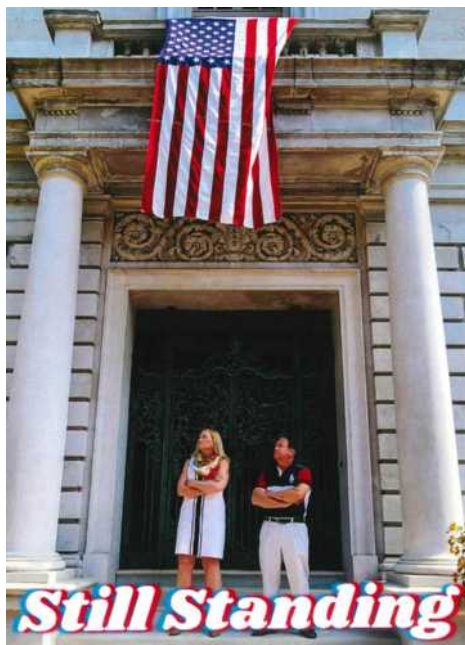
Mark was born and raised in the St. Louis, Missouri suburb of Webster Groves, and is a life-long Republican. He attended St. Louis Country Day School, where he was captain of the wrestling team, and President of the Student Council.



He graduated magna cum laude from Southern Methodist University, with degrees in Psychology, Sociology, and Criminal Justice. He went on to receive his law degree from SMU as well, and has spent the last 36 years representing the rights of his fellow citizens.

Mark has been married to his wife Patty for 36 years, and they have one adult daughter.

On June 28, 2020, and then again on July 3, 2020, he and Patty held off a violent mob through the exercise of their 2nd Amendment rights. Since then, they addressed the Republican National Convention, and have been frequent guests on Fox, Newsmax, OAN, CNN, and a variety of national and local news and talk TV and radio programs. They campaigned extensively in support of Donald Trump, and continue to speak around the nation on their support of the Constitution, the traditional values that have made the USA the greatest nation on Earth, and the current threats to its continued existence.



Mark has never before run for political office, but he has now answered the call of public duty, and is running for the United States Senate from Missouri, to fill the seat of retiring Senator Roy Blunt.

Greetings Fellow Republicans,

I would like to introduce myself with a brief background for those of you who do not know me. I was born and raised in Adams County. My wife Theresa and I will have been married 42 years next Wednesday, we have three children and nine grandchildren. Our grandchildren are the seventh generation on our soon to be sesquicentennial farm in Adams County. I have been involved in local politics since the early 1990's. I served on the Adams County Board from 1994 – 2008, most of those years as Chairman of the Legislative and Judicial Committee and Vice-Chairman of the Board. I had been serving as the Vice-Chairman of the Republican Central Committee since 2014 under Chairman Laura Kent Donahue. When Laura was appointed to the Illinois State Board of Elections in 2019, I filled out the remainder of her term and was elected to my own term in 2020.



While National and State election results are beyond our control, I will point out that Adams County voters demonstrated better judgement than the rest of the country and state, and supported our Republican ticket up and down the ballot by extremely large margins. We are fortunate to have Darin LaHood as our U.S. Representative, Jil Tracy as our State Senator, Randy Frese as our State Representative, Gary Farha as our State's Attorney, Jill Reis as our Regional Superintendent of Schools, Ryan Niekamp as our County Clerk, Bryden Cory as our County Treasurer and Scott Graham as our County Coroner. We have also elected several Republican Judges over the last few years. Next November we will elect Tony Grootens as the next Adams County Sheriff and the only countywide office we will not hold is Circuit Clerk. Mike Troup was elected Mayor of Quincy this past spring succeeding Kyle Moore and we have a 9-5 majority on the city council. Lastly, we also hold an 18-3 super majority on the Adams County Board. We must not become complacent though, because there are new people in charge of the other party that are aggressive and far left.

Fundraising is the most difficult part of this job. I welcome you to our Lincoln-Reagan Dinner. I thank you for attending and give many thanks to our advertisers in this book. Last, but certainly not least, thank you to our Precinct Committeepersons for all they do.



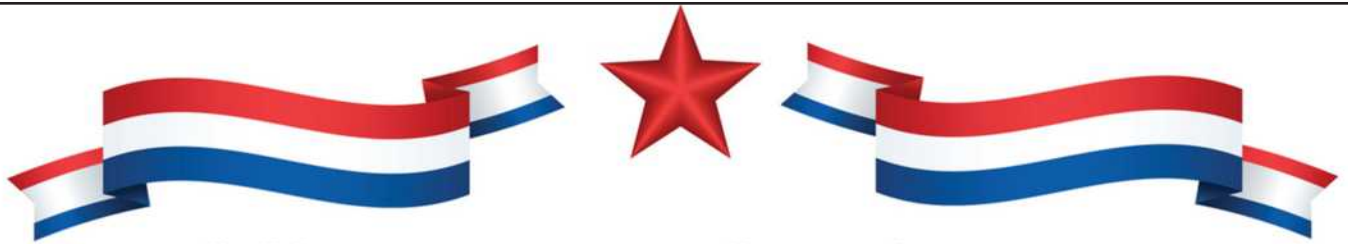

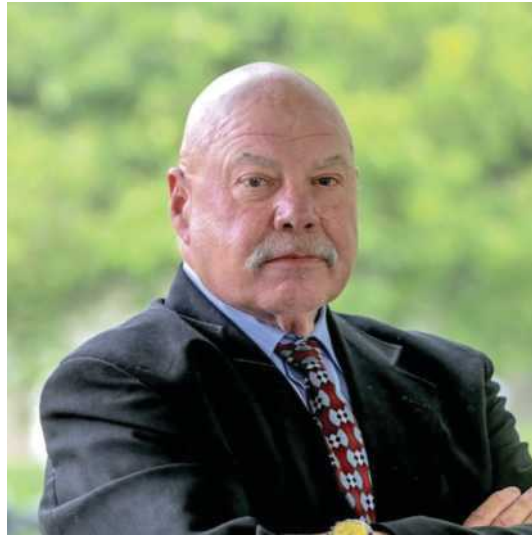

Tony has a proven track record with the (DEA), having held leadership roles in Springfield, Illinois, Springfield, Missouri, El Paso, Texas, & Anchorage, Alaska. Tony was responsible for Federal Drug Enforcement efforts in Central Illinois, with cases targeting major criminal enterprises. He developed strategic plans to dismantle large, organized narcotic distribution networks throughout Central Illinois.
